

1. Assembly:

- Ethics related activities at the school during the assembly should be carried out on the following themes:
Theme: 1 Daily short speech of few minutes during assembly on each topic as deem appropriate. The activities may be carried out by students on rotation basis.
Theme: 2 Few minutes topic-based demonstration in the form of skits by a group of students.
- Hence, out of six days a week, three topics can be demonstrated at the assembly, each topic for speech on day-1 and for demonstration as a skit on day-2.

2. Bazm-e-Adab:

- Bazm-e-Adab (emphasizing on ethics related activities) will be arranged positively on last working day as per detail given below and report regarding the activities carried out in the Bazm-e-Adab shall be kept on record and a copy of the same may be sent to District Education Officer (Concerned).
- Periods/Classes
- Period Bazm-e-Adab (School closed for students)
- Last 3 periods staff meeting and completion of class registers.
- Break is optional according to the local situation of institutions.

All the District Education Officers (M&F) including Merged Districts Khyber Pakhtunkhwa are directed to circulate the above schedule to the Head of Primary/Middle /High and Higher Secondary Schools under their jurisdiction for compliance with immediate effects in letter and spirit.

<u>20/06/2025</u>	<p><u>WP No. 3911-P/2025</u></p> <p><u>Present:</u> Mr. Noor Muhammad Khattak, Advocate, for the petitioner.</p> <p>Mr. Muzammil Khan, AAG, for the respondents.</p> <p style="text-align: center;">==</p> <p><u>SYED ARSHAD ALI, J.-</u> Hazrat Muhammad and 06 others, who are Subject Specialists in the Elementary & Secondary Education Department of Khyber Pakhtunkhwa, have filed the instant Constitutional Petition praying that:</p> <p style="padding-left: 40px;"><i>"It is therefore, most humbly prayed that on acceptance of this writ petition the action of the respondents by issuing the impugned notification dated 11/10/2024 whereby the duration of period has been enhance/increased to forty five (45) minutes may kindly be declared as illegal, unlawful, unconstitutional and ineffective upon the rights of the petitioners. That the respondents may please be directed to kept intact the duration of period as 40 minutes instead of 45 minutes in light of previous notification dated 09/10/2018 in the best interest of students as well as teachers. Any other remedy which this august Court deems appropriate may kindly also be granted in favour of the petitioners".</i></p> <p>2. The learned counsel for the petitioners, while referring to the Notification dated 09.10.2028 issued by the worthy Secretary Government of Khyber Pakhtunkhwa Elementary & Secondary Education Department, has argued that the competent authority has directed that all Subject Specialist/DPEs and Librarians shall</p>

observe school official time according to the time table issued by the Director Elementary & Secondary Education Khyber Pakhtunkhwa Peshawar vide letter dated 05.01.2018 i.e. six subjects in six periods of duration of 40 minutes along with Nazira and Morning Assembly, however, the Director Elementary & Secondary Education through a subsequent Notification dated 11.10.2024 has increased the time duration of the period from 40 minutes to 45 minutes and as well as the number of subjects per day, therefore, the Director Elementary & Secondary Education has no jurisdiction to have issued the impugned Notification contrary to the directions of the Secretary Elementary & Secondary Education Department. These assertions of the learned counsel for the petitioners could not impress us because the close perusal of the Notification dated 09.10.2028 would clearly show that the worthy Secretary Elementary & Secondary Education Department has not issued any Notification on his own but has issued the directions that the earlier Notification relating to the duration of period issued by the Director Elementary & Secondary Education should be implemented. It is the said Director. who has altered/increased the time period of one period by 05 minutes vide impugned Notification dated 11.10.2024. The Government is not only competent but also has the mandate to regulate the affairs of schools and to provide guidelines and policies for effective class management. Neither the petitioners

have any locus standi to challenge the said regulatory framework/policy matter of the Provincial Government, which is being issued in the public interest nor this Court has any jurisdiction to interfere in the policy matter of the Government, which is otherwise reasonable and is based on public interest.

3. Resultantly, we find no merit in this petition, which is accordingly dismissed in limine.
